SECTION 1

SECTION 2 - CONSENT

If we ever ask for personal information for a secondary reason, such as marketing, we will directly ask you for your consent and provide the opportunity to say no.

SECTION 3 - DISCLOSURE

Personal information will not be disclosed, we will only be required to disclose your personal information, by virtue of Law, in court or if the User violates our Terms of Use.

SECTION 4 - THIRD PARTY SERVICES

In general, third-party vendors used by us will only collect, use and disclose your information as necessary to enable them to perform the services that they provide to us.

However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies with respect to the information we are required to provide to them from their purchase-related transactions. For these suppliers, we encourage you to read their privacy policies, so that you can understand how your personal information will be used by those suppliers.
